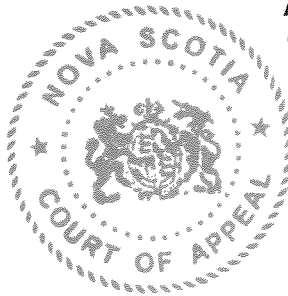

UPON the Appellant filing a motion to set the date and directions for the hearing of the appeal in this matter;

AND UPON hearing Marjorie A. Hickey, QC and Jane O'Neill, on behalf of the Appellant, and Brian Casey, QC, on behalf of the Respondents;

IT IS HEREBY ORDERED THAT:

1. This appeal will be heard on April 6, 7, and 8, 2016;
2. The Appellant and the Respondents shall each file a factum limited to 60 pages;
3. The filing of the Appeal Book shall be subject to the following:
 - (a) The Record forming the basis for the judicial review application in the court below shall be filed electronically as part of the Appeal Book, accompanied by a paper copy of the key extracts from the Record relied upon by the parties;
 - (b) The transcript of submissions in the court below shall be filed both in paper copy and electronically;
 - (c) The Appeal Book shall include paper copies of the parties' written submissions; and
 - (d) The Appellant shall provide electronic versions of the Appeal Book for the Intervenors, unless an Intervenor specifically requests a paper copy to be provided.
4. Filing dates shall be as follows:

On or before September 30, 2015	Appellant to file Appeal Book
November 24, 2015	Appellant to file factum
November 24, 2015	Respondents to file factum on issues raised in Notice of Contention

December 18, 2015	Intervenors in support of Appellant's position to file facta
February 1, 2016	Respondents to file factum
February 1, 2016	Appellant to file response on issues raised in Notice of Contention
February 26, 2016	Intervenors in support of Respondents position to file facta
April 6, 7, 8, 2016	Appeal to be heard
